

Planned Giving



Why we need your help

Your regular giving, preferably by Bank Standing Order:

- provides the Parish with regular income towards costs of around £6,000 each week;
- helps us take responsible decisions about the work of the parish;
- makes possible the recovery of tax from the Government.

Giving by Gift Aid costs you nothing:

- It allows 20p of tax to be reclaimed for every 80p you give.
- Signing the declaration form costs nothing and does not affect tax codings.
- Higher rate taxpayers can reduce their tax bill by 25p for every £1 they give. Top rate taxpayers can recover even more.

Giving profile

In 2019 we received £194,000 from 144 regular givers.

In considering how much to give you may wish to be aware of the breakdown of what we currently receive:

56% of planned giving comes from 18% of givers: please be generous and help us spread the load more.

Recently, a typical contribution from new givers has been about £50 per month.
